As a longtime member of the Peninsula Corridor Joint Powers Board he led efforts to modernize Caltrain service on the Peninsula. Mr. Lloyd left an impression on everyone he met. Chair Kersteen-Tucker requested that today's meeting be adjourned in memory of Mr. Lloyd.

Recommend Appointment of Michelle Buzbee, Representing Multimodal Riders, to the Citizens Advisory Committee (CAC)

Committee Chair Gee thanked Directors Charles Stone and Karyl Matsumoto for their time on the interview panel for the public member seats on the Board. Ms. Buzbee rose to the top in the interviews, but unfortunately only two appointments can be made to the Board. Ms. Buzbee lives on the Coast and is a high school junior. Committee Chair Gee said given that youth is an increasing demographic for SamTrans the committee unanimously recommends Ms. Buzbee be appointed to the CAC.

Director Rose Guilbault said she and Director Shirley Harris had a chance to meet Ms. Buzbee at the Youth Leadership Institute presentations held in the auditorium and was very impressed with her. She will be a tremendous asset to the CAC.

Accessibility Update

Tina Dubost, Manager, Accessible Transit Services, said at the November SamTrans Accessibility Committee meeting there was a discussion on the replacement of the 40-foot buses in 2017.

Director Matsumoto said in the PCC minutes there was a discussion on Alameda County's Measure B and BB funding paratransit and asked if the District should go out for a ballot measure to support seniors and paratransit funding. Ms. Dubost said Alameda's measure is set-up different than San Mateo County's Measure A.

Paratransit Coordinating Council (PCC) Update

Mike Levinson, Chair, PCC, said there are multiple organizations in the East Bay that help with paratransit funding. The PCC's Regional Conference will be February 7 or 20 in the SamTrans auditorium.

Chair Kersteen-Tucker asked about the consumer core rides and the reason no trips were reported for the Coast. Mr. Levinson said at every meeting volunteers are sought to participate.

Citizens Advisory Committee (CAC) Liaison Report

Committee Chair Gee said a report from CAC Chair Juslyn Manalo is included in the reading file. He said Directors Peter Ratto and Harris and Mark Simon, Chief of Staff, attended the CAC's holiday reception prior to their meeting. Lindsey Kiner, Senior Planner, presented the District's Draft Short-Range Transit Plan and Margo Ross, Director, Bus Transportation, reported the October performance statistics.

Mobility Management Report – Fixed-Route Bus

David Olmeda, Chief Operating Officer, Bus, said there continues to be a decline in ridership. Between last year and through October there is about a 12 percent decline in ridership. Mr. Olmeda said although this is alarming it parallels with ridership in neighboring transit agencies as well as on a national scale. In terms of farebox revenue it is essentially a function of ridership so it is also showing a decline. Mr. Olmeda said token usage and Day Pass usage also reflects the same trend. He said SamTrans offers a variety of fare media so in subsequent reports he will provide a more comprehensive look at the fare media and how they are performing.

Mr. Olmeda said after the SamTrans Service Plan was implemented ridership numbers passed the national average significantly for two years.

- Ridership versus the national comparison:
 - Fiscal Year (FY) 2012-2013 was -2.2 percent versus 0.4 percent
 - FY2013 –FY2014 was 3 percent versus -0.7 percent
 - FY2014-FY20458 was 2.9 percent versus -1.6 percent
 - FY2015-FY2016 was 2.8 percent versus -1.9 percent
 - FY2012-FY2016was 0.8 percent versus -4.7 percent
 - First quarter of FY2017 was -5.28 percent versus -5.1 percent

Mr. Olmeda said what is significant about the first quarter of FY2017 is staff has seen a significant rate of decline in the national ridership and SamTrans is seeing that too. One of the contributing factors is the sustained cost of low fuel. When staff looked at the decrease in the cost of fuel from the same time period, fuel is down 40 percent.

Mr. Olmeda said on-time performance (OTP) is impacted by the heavy flows of traffic in the county, even the CUB and Coastsides service providers are affected. Although adjustments have been made to some routes to correct the OTP the effect of traffic is manifesting itself into the OTP of the system.

Mr. Olmeda said SamTrans has a very good safety record. In FY2015 the goal of 115,000 miles between service calls was exceeded. But the sensitivity of the metrics is as delicate as one accident per month will cause the metric to not be met.

Mr. Olmeda said fleet reliability remains outstanding. In the last month it was over 30,000 miles between service calls. This also helps with the missed schedule statistic. When the fleet is reliable there is no potential for missed schedules. This is significant because of the customer service and customer experience being offered. When there are five-minute or 15-minute headways and a schedule is missed it doesn't affect the customer. When there are 30-minute or hour headways and the run is missed it is significant impact to those customers. Customer reports are very good with less than 150 complaints for every one million trips.

Mr. Olmeda said in 2017 the goal is to improve ridership by evaluating ridership performance on low performing routes and low performing trips. Staff wants to identify new area service options such as express service, pilot programs, or new markets that can be served. He said staff will be evaluating express and pilot service fares as well as ways to improve response time for service changes.

Director Matsumoto said lower gas prices are one factor to declining ridership, but what are two others. Mr. Olmeda said the County has low unemployment rates and a healthy economy allows people to have choices on where they work. The high cost of housing in the County discourages people from living here.

Director Adrienne Tissier asked if Uber and Lyft have an effect on ridership. Mr. Olmeda said Bay Area Rapid Transit (BART) has experienced this on their San Francisco International Airport (SFO) and Oakland Airport stops.

Chair Kersteen-Tucker said staff speculates why people aren't riding, but is there a way to find out why people aren't riding. Jim Hartnett, General Manager/CEO, said there is no answer. Surveys and focus groups can be done, but it is evident low gas prices is causing the decline in ridership. Staff knows the trends, but looking at why people don't want to ride or not riding is a not easy. This is why staff is looking at express bus routes. Caltrain riders benefit from Uber and Lyft for their first and last mile.

Chair Kersteen-Tucker said staff and the Board must speculate the choice riders are the ones that have been lost. Mr. Hartnett said lower gas prices, a good economy and people have more money to spend and may be using a vehicle where they didn't have it before.

Director Guilbault asked about the role within marketing on ridership and people's negative perception. There are populations that need the bus. Director Guilbault said a solid marketing plan would support goals and make a realistic perception of SamTrans. She asked when the Board will receive an update on the goals. Mr. Olmeda said the new routes launched were a partnership with the marketing department. Anytime there are service changes marketing does promotions and puts the information out to the riders. Mr. Olmeda said by February he hopes to have the ridership dashboard data for the Board. This dashboard serves as a report card for the staff in the field.

Mr. Hartnett said he will have Seamus Murphy, Chief Communications Officer, provide a presentation on what goes into marketing new routes and service adjustments. He said with the new school routes staff worked with the community.

Multimodal Ridership Report – October 2016

Mr. Olmeda reported:

- Compared to September 2015
 - Average Weekday Ridership
 - Bus ridership was 42,500, a decrease of 9.2 percent.
 - Paratransit ridership was 1,320, an increase of 1.5 percent.
 - Caltrain ridership was 58,810, a decrease of 3.5 percent.
 - Shuttle ridership was 12,950, an increase of 13.5 percent.
 - Total weekday ridership was 166,090, a decrease of 3.9 percent.

Mr. Olmeda said the increase in shuttles is an indicator of a strong economy as these are funded by the employers.

- Total Monthly Ridership
 - Bus ridership was 1,075,180, a decrease of 12 percent.
 - Paratransit ridership was 31,940, an increase of 1 percent.
 - Caltrain ridership was 1,570,820, a decrease of 5.4 percent.
 - Shuttle ridership was 272,520, an increase of 7.1 percent.
 - Total weekday ridership was 4,224,420, a decrease of 7 percent.

Committee Chair Gee said as chair of Commute.org they are seeing an incredible increase in the shuttles. There is a core group of customers that need the service and there is another audience that may be more likely to ride if the bus was like a Google bus with leather seats and Wi-Fi.

Director Peter Ratto said shuttles are geared to provide service from Caltrain with a seamless connection. The most popular destination for Uber service is the San Francisco Caltrain Station because of the unreliable service in that area.

Mr. Hartnett said at the request of Santa Cruz Transit he met with their General Manager to discuss service on Highway 17 to Diridon Caltrain Station. During the meeting it became apparent the meeting was to actually ask for assistance in subsidizing their Highway 17 shuttle. The community service was being cut and the general manager said he couldn't cut that service without cutting their premium Highway 17 service.

WELCOME/INTRODUCTION

Chair Mike Levinson called the meeting to order at 1:30 p.m. and welcomed all to the November PCC meeting.

APPROVAL OF THE OCTOBER PCC MINUTES

Vincent motioned to approve the October PCC meeting minutes and Judy seconded the motion. Michal abstained from voting and no corrections were noted.

COMMITTEE REPORTS

A. POLICY ADVOCACY- LEGISLATIVE COMMITTEE (PAL)

Vincent reported on a variety of demand responsive services that are offered in neighboring Bay Area counties.

The PAL Committee discussed how the San Mateo County Transit Authority (TA) administers Measure A funds. Tina reported on the differences in the three different Measure A sales taxes in San Mateo County.

Mike said that the PAL Committee also discussed the transition some transit agencies are making from MDC's (Mobile Data Computers) and MDT's (Mobile Data Terminals) to tablet-based data collection on paratransit vehicles.

The next PAL Committee meeting is scheduled for Tuesday, December 13, 2016. A Bus Review Committee is tentatively scheduled to take place before the December PAL Committee meeting. Tina will send out a date and time confirmation for the Bus Review Committee.

B. GRANT/BUDGET REVIEW

Barbara reported that there are no updates available.

C. EDUCATION COMMITTEE

Sammi reported that two outreach events took place in October. The PCC hosted a table at the Transition to Independence Fair in South San Francisco and the Seniors on the Move Conference in San Mateo. Both events were very well attended. The last of the PCC-branded coin purses have been given out and the new pens are being distributed. Erin and Sammi will work with the rest of the Committee members to set an Education Committee conference call for December or early January. Sammi thanked the volunteers who worked at both events.

D. EXECUTIVE COMMITTEE

Mike reported that the Executive Committee held a conference call on November 1, 2016. The Committee is working to plan a PCC Regional Conference for February. A date, theme for the conference, and topics of interest are also being developed. Michal Settles asked about where the PCC Regional Conference will be held. Mike reported that the conference will either be held at the SamTrans building or at another nearby location.

The Executive Committee also worked to get an update from SamTrans on the IVR program status, as this project has been in progress for several years. An update on the performance level is also needed. Vincent and the PCC members discussed the original timeline for implementing the IVR program. Margo reported that getting the IVR program assessed and fully operational is a high priority. Margo said that she is negotiating with the vendor to set a meeting date and Tina is developing a scope of work to complete the project. Vincent asked for monthly updates about progress on the IVR program. Mike asked Margo about adding enhanced service from Trapeze if a contractual credit is due from the IVR program. Sandra asked if SamTrans oversees the IVR project contract. Michal thanked Margo for her report and commitment to solving the IVR problems. Margo agreed to attend the February PCC meeting and provide an update. Michal asked if the SamTrans Board of Directors is aware of the issues with the IVR project. Patty asked for a dollar amount that is spent monthly and annually that are allocated toward the part of the project that is not fully functional.

SAMTRANS/REDI-WHEELS REPORT

A. Operational Report

Tina reported that Santa Clara VTA has changed their paratransit provider from Outreach to work with MV Transit directly. Tina has no reports that Redi-Wheels customers have been affected, although she has heard that some customers in Santa Clara County have been impacted. Aki and John discussed when new reservations are going to be taken for VTA paratransit trips.

The SamTrans Route #294 service to the Half Moon Bay Pumpkin Festival was expanded for this year's event.

B. Performance Measures Report

Tina reported that total ridership in September 2016 was about 3.6% higher than September 2015. Average weekday ridership is also higher. On-time performance and

productivity both met the standard, along with telephone hold time. The number of taxi trips is trending upward.

Monica acknowledged the increased demand and expense for paratransit services in San Mateo County. Tina said that the current Redi-Wheels budget is about \$18 million dollars per year. Ashish reported that in the budgeting process, SamTrans analyzes seasonal trends and PPH (passengers per hour) trends to forecast projected expenses. Ashish said that the ridership increase is expected to stabilize. Other factors include staffing, vehicle allocation, routes, and vehicle inspections to set costs and service delivery as accurately as possible. Dinae asked about the trend of taxi rides increasing. Dave reported that taxi use is dictated by average daily ridership. SamTrans is working to expand their fleet and First Transit is working to add staff as-needed. Mike asked Dave discussed fixed and variable costs for First Transit. Sandra and Ashish discussed how comparative data for different demographic groups is used to project ridership data. Michal asked Sandra if the COA collects data on senior citizens projected to be moving into San Mateo County. Marie added that the existing aging population residing in San Mateo County is expected to need increasing services.

Mike reported that a series of four stakeholder workshops will be held at SamTrans over the next year to address the aging and adult population. The first workshop is scheduled to take place from 9:00 a.m. to 12:00 p.m. on Monday, November 14, 2016. Melissa Reggiardo is the contact person at SamTrans for the first workshop.

C. Monthly Redi-Wheels Comment Statistics Report

John reported that broad trends continue upward. In 2016, there have been 43 valid late vehicle complaints so far this year. John calculated that the number of valid late vehicle complaints per 1000 trips is far less than 1%.

Mike asked John about feedback about customer behavior reported by Redi-Wheels drivers. John and Margo- commented that gathering the data would be highly time-consuming for the small number of complaints received. Dave said that SamTrans does respond to driver reports about issues with customers.

Safety Report

Dave reported that in August in September there were zero preventable accidents. In October, there were two preventable accidents. Both drivers involved with the preventable accidents completed retraining. No injuries were reported. Dave said that a vehicle maneuvering exercise is being planned for the next Safety Meeting that includes all the drivers.

LIAISON REPORTS

A. COASTSIDE TRANSPORTATION COMMITTEE (CTC)

Michal reported that the next CTC meeting is scheduled for December 15, 2016. A Christmas celebration has not yet been planned. Maintaining driver staffing levels has been easier, with some long-term employees returning to work on the Coastsides. The Half Moon Bay Pumpkin Festival had low attendance due to poor weather this year.

Michal agreed to send out a Coastsides meeting reminder prior to the December PCC meeting.

B. AGENCY

Barbara reported that the agencies periodically get a large group of new drivers, when the routes go up for bid. She said that the new driver bid is now in place and there have been no problems to report. Dave credited Oliver for all his hard work coordinating the routes for the agencies.

C. EFFICIENCY REVIEW COMMITTEE (ERC)

Mike reported that an ERC meeting has not been scheduled for November or December. Tina agreed to contact the Committee members to set up a meeting.

D. COMMISSION ON AGING (COA)

Sandra reported that the COA met on October 17, 2016. The Transportation Committee also met that day. The Transportation Committee has developed a pedestrian safety toolkit for distribution by the San Mateo County Commissioners to the municipalities. This project is part of the updated 2006 Senior Mobility Plan. Sandra said that a presentation about Fall Prevention was given at the October COA general meeting. The COA is continuing to distribute Elder Abuse Awareness brochures. The next COA meeting is scheduled for 9:00 a.m. on Monday, November 14, 2016 at 225 - 37th Avenue in San Mateo. Mike said that the last New Beginnings Coalition meeting had a presentation given by the TIES information service about Elder Abuse Awareness.

E. COMMISSION ON DISABILITIES (COD)

Vincent reported that on October 15, 2016, the Transition to Independence Fair took place in South San Francisco. The event was well-attended and Vincent thanked the PCC for participating. The COD Executive Committee is working to strategize priorities for the coming year and will also be rescheduling the 25th anniversary BBQ for early 2017.

F. CENTER FOR THE INDEPENDENCE OF INDIVIDUALS WITH DISABILITIES (CiD)

Vincent reported that CiD is hosting four movie screenings over the next few months at the Gatepath office in Burlingame (899 Stanton Road).

G. DEPARTMENT OF REHABILITATION (DOR)

Susan reported that some counselor and clerical vacancies at DOR are still open. Lots of referrals are being given and outreach activities are taking place. Susan said that the building manager has worked with clients and employees at DOR to assist them as the offices have been under extensive renovation.

OTHER BUSINESS

Mike announced that the next PCC meeting is scheduled for Tuesday, December 13, 2016 at 1:30 p.m.

Tina said that a Bus Review Committee will be scheduled, once the grant funding for a new cutaway bus is approved. Margo described the specific restrictions on vehicle purchases with grant funding. Tina said that a standard cutaway currently costs about

\$100,000 and low-floor cutaway vehicles cost about \$150,000. Tina said that the low-floor vehicles are appealing because riders can board more quickly and easily. Sammi pointed out that one drawback to the low-floor vehicles is there is only space for two wheelchairs. Dave said that about 57 buses in total are in service each day. Barbara and Mike expressed concern about low-floor vehicles navigating along steep hills and driveways throughout San Mateo County. Vincent advocated for holding the Bus Review Committee meetings on the same day as the regularly-scheduled PCC meeting.

Aki shared his insights into the IVR project that he has had over the duration of the time that it has been in progress.

Dale said that he is thankful for the PCC and the paratransit service provided by Redi-Wheels. He noted that the PCC represents over 7,000 riders in San Mateo County. Dale wished everyone a Happy Thanksgiving.

APPROVAL OF OCTOBER PAL MINUTES

Mike motioned to approve the October PAL meeting minutes and Sammi seconded the motion. No abstentions or corrections were noted.

LEGISLATIVE UPDATES

Tina reported on the issues with VTA Access Paratransit in Santa Clara County. She said that VTA made a sudden change to its service provider from Outreach to MV Transportation. There have been some service disruptions this week. John said that MV Transit was already a transportation subcontractor for VTA, so they should be able to continue providing service in this transition and participate in the RFP process.

LOCAL ADVOCACY ISSUES—OPEN DISCUSSION

Mike asked Tina for an update on the policy for Inter-County Transfer Trips with Outreach. Tina said that Redi-Wheels is providing the new phone number for VTA/Outreach to customers who call to make inter-county transfers.

Mike reported on a voting guide sent out by MTC.

Aki asked for information about the High-Speed Rail Project and electrification vs. Maglev train technology.

POLICY ISSUES

Vincent provided an update on neighboring transit agencies. In San Francisco, he said that SF Access is moving away from Mobile Data Computers (MDC's) and transitioning to tablets. MDC's cost about \$4,000 apiece and tablets cost about \$100.00. While the life span of the MDC's is longer than a tablet, the tablets are much easier to replace. Tina confirmed that the MDT's used by SamTrans are radio-based, while tablets would rely on cellular transmissions.

John clarified the differences between MDT's and MDC's (Mobile Data Computers). The computing terminals collect a greater amount of data while the vehicle is in

service. Dave said that VTA is piloting the Driver Mate Tablet made by Trapeze. He said that First Transit will be following progress on the project. John, Tina, and Dave discussed the cost of add-ons to Trapeze. John and Tina clarified that the IVR component of Trapeze used by SamTrans is currently in use, specifically for Night Before Calls. John said that there are several costs related to implementing IVR. Tina added that Imminent Arrival Calls have not yet been implemented because the accuracy of ETA's is not high enough at this point. Vincent asked for specific details about the next steps needed to move forward on the Imminent Arrival Call implementation. Aki and Dinae reported that they did not receive a Night Before Call for their trip to SamTrans today.

Vincent reported that UCSF and HPSM recently reached an agreement for patients. Vincent said that SF MTA would welcome a direct service agreement with SamTrans to UCSF. Tina said that funds and staff are not presently available at SamTrans to offer expanded paratransit service to UCSF.

Vincent and John discussed Same-Day Service with SF Access. The Wheelchair Breakdown Service provides transportation for individuals which may not be provided via paratransit.

Vincent stated that in Marin County, a packet of transportation vouchers is provided to individuals who receive SSI. Marin Transit has partnered with Aging and Adult Services to work on grant applications. Tina commented that Marin is working to implement a Senior Mobility Volunteer program, while SamTrans has been providing this service for the past several years. Vincent commented that a Mobility Consortium has been established to collaborate with organizations in the community. The SamTrans Planning department is working on a SamTrans Mobility Plan for Seniors and People with Disabilities. Mike, John, and Tina discussed the four meetings taking place over the next year to work on the Plan. Another planning document will be workshopped for youth services.

Vincent stated that he has been working with Richard to develop a matrix for Paratransit Service in the 9 Bay Area Counties.

Mike and Tina discussed how the San Mateo County Transportation Authority (TA) administers money from Measure A. Tina described a breakdown of the spending allocated for various transit and paratransit projects in San Mateo County. San Mateo County voters originally passed Measure A in 1988. That Measure created a ¼ cent sales tax for transportation in San Mateo County, and created the TA to administer the revenue. The 1988 Measure included the establishment of a \$25 million paratransit trust fund, with the assumption that the interest would provide all the funding necessary for paratransit, forever. (In FY 2016 the trust fund yielded approximately \$200,000 in interest.) Measure A was re-authorized by the voters in 2004, and took effect in 2009. The Measure A reauthorization specified that approximately 4% of the funds collected will go to accessible services, until the measure sunsets in 2033. Mike asked Tina for guidance on how to approach the TA to advocate for additional paratransit service.

San Mateo County voters also passed a separate ½ cent sales tax, also called Measure A in 2012. The 2012 Measure A is administered by the County of San Mateo, and allocated by the San Mateo County Board of Supervisors in two-year grants for a variety of programs. The Board of Supervisors has contributed \$5 million per year to Redi-Wheels and RediCoast, for the past three years, and has committed to \$5 million for one additional year, after which the grant must be reauthorized or alternate funding identified. About the San Mateo County Board of Supervisors Measure A, Mike also asked about how paratransit advocacy could take place.

Vincent, John, and Tina discussed the differences between services provided by the Alameda County Transportation Commission (ACTC) and East Bay Paratransit.

Vincent asked Tina for the level of reserves that SamTrans has for this budget year. Tina and Vincent discussed Same-Day demand response service in different parts of Alameda County. Dave and John discussed how premium service might be implemented in the future for the VTA Outreach Program. Vincent described how the ACTC is funding a variety of beyond-ADA paratransit programs through the Alameda County Sales Tax Measure B. Tina and John discussed how the San Mateo County Measure A is structured differently from the Alameda County Measure B. Sammi commented that improving existing ADA paratransit service should be a higher priority over expanding ADA service.

Vincent discussed additional above-ADA services that could be implemented by SamTrans. The PAL Committee members discussed how the cost of expanding ADA services at SamTrans could be quantified.

Tina confirmed that the SamTrans Executive Committee is comprised of the SamTrans Chief Officers.

OTHER BUSINESS

Tina reported that funding for a new low-floor cutaway has not been confirmed. She said that the low-floor cutaway vehicles cost about \$50,000 more than a traditional cutaway vehicle. Tina suggested having a Bus Committee meeting in December to discuss replacing Redi-Wheels minivans and another meeting in January to discuss the low-floor cutaway vehicles. Tina said that the Bus Review Committees would be scheduled to take place before the PAL Committee meeting in December 2016 and January 2017.

Mike reported that the PCC will meet today from 1:30 to 3:30 p.m.

The next PAL meeting is scheduled for Tuesday, December 13, 2016 from 11:30 a.m. to 12:30 p.m.

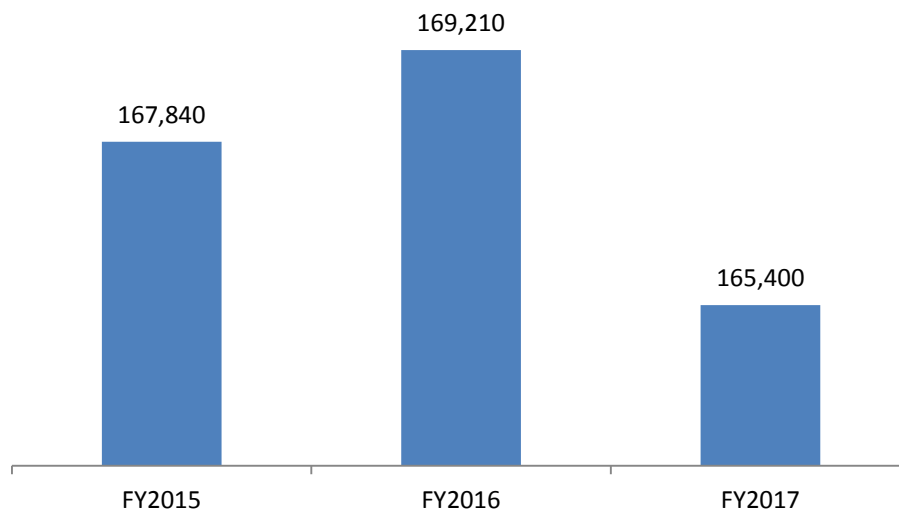

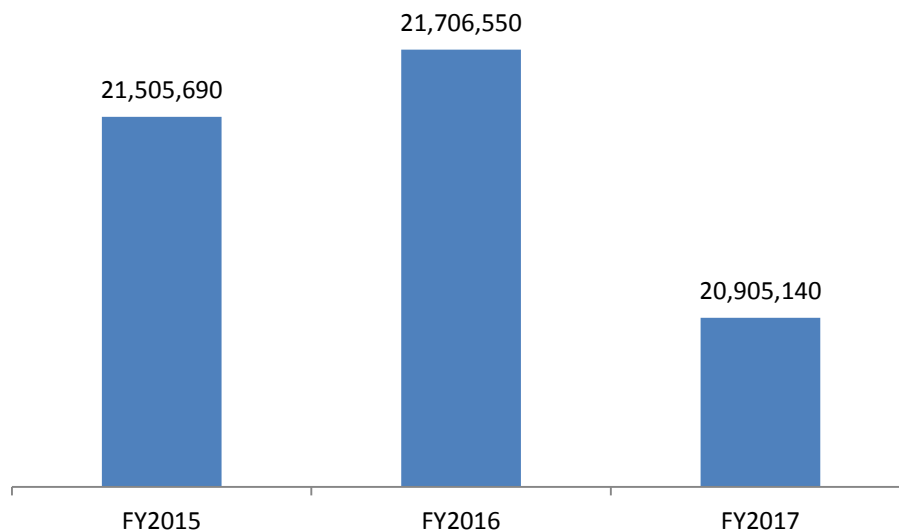

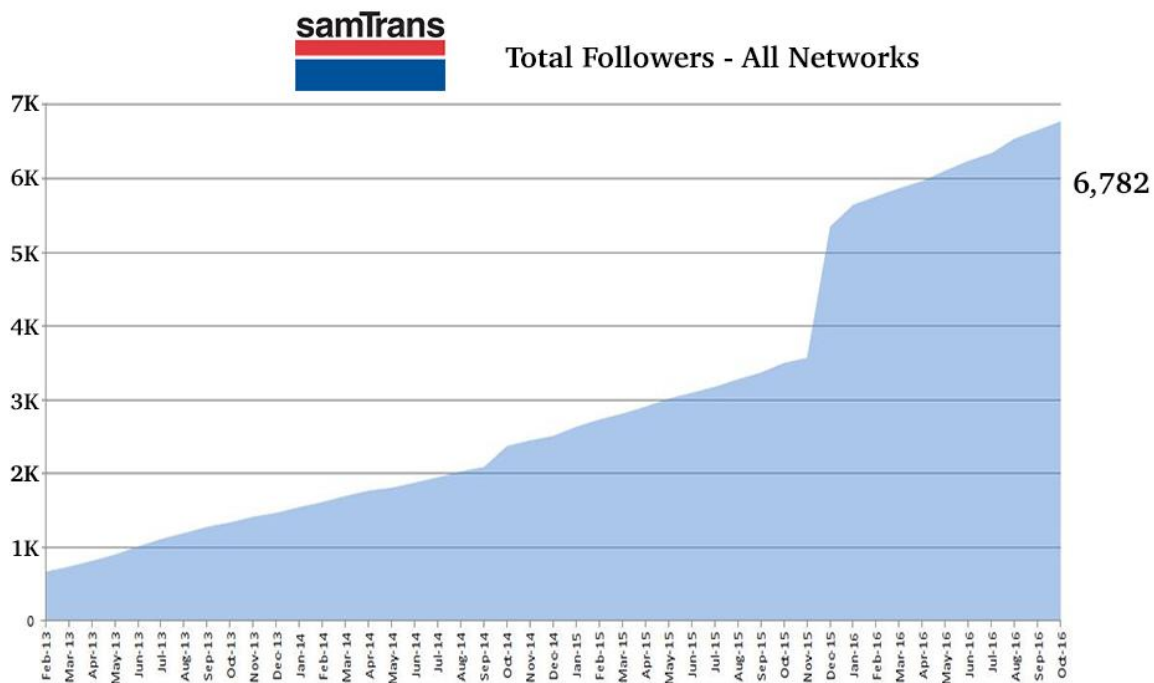
SamTrans Promotions – November 2016

Expenses: *Total Expenses* (page 4, line 71) are \$4,668,577 or 7.7 percent **better** than revised budget. Within Total Expenses, *Total Motor Bus* (page 3, line 46) is **better** than budget by \$4,072,730 or 8.2 percent, *Total ADA Programs* (page 4, line 55) is **better** than budget by \$514,811 or 6.8 percent and *Total Multi-Modal Programs* (page 4, line 69) is **better** than budget by \$81,036 or 2.2 percent.

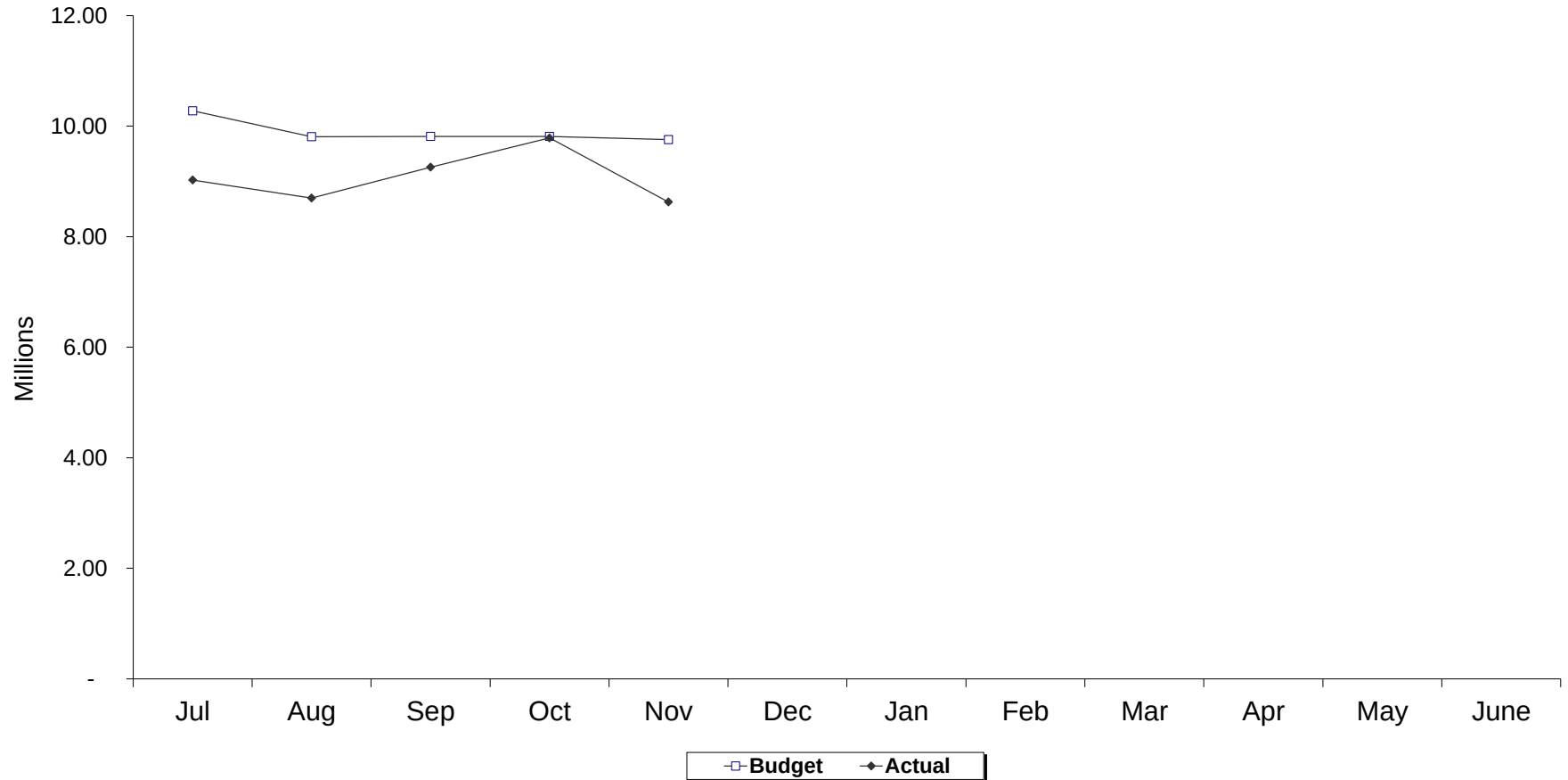

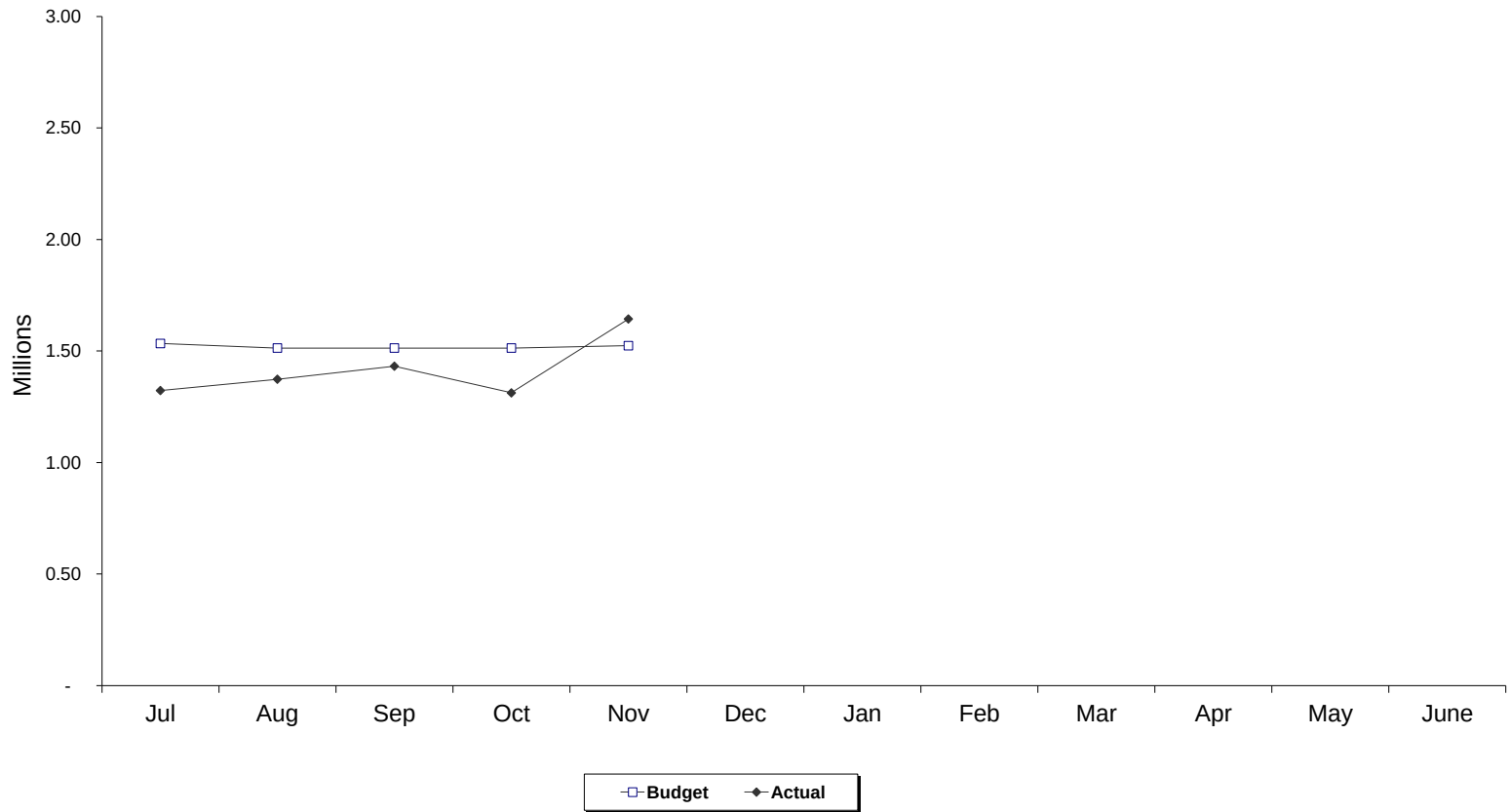
MOTOR BUS MONTHLY EXPENSES - BUDGET VS ACTUAL

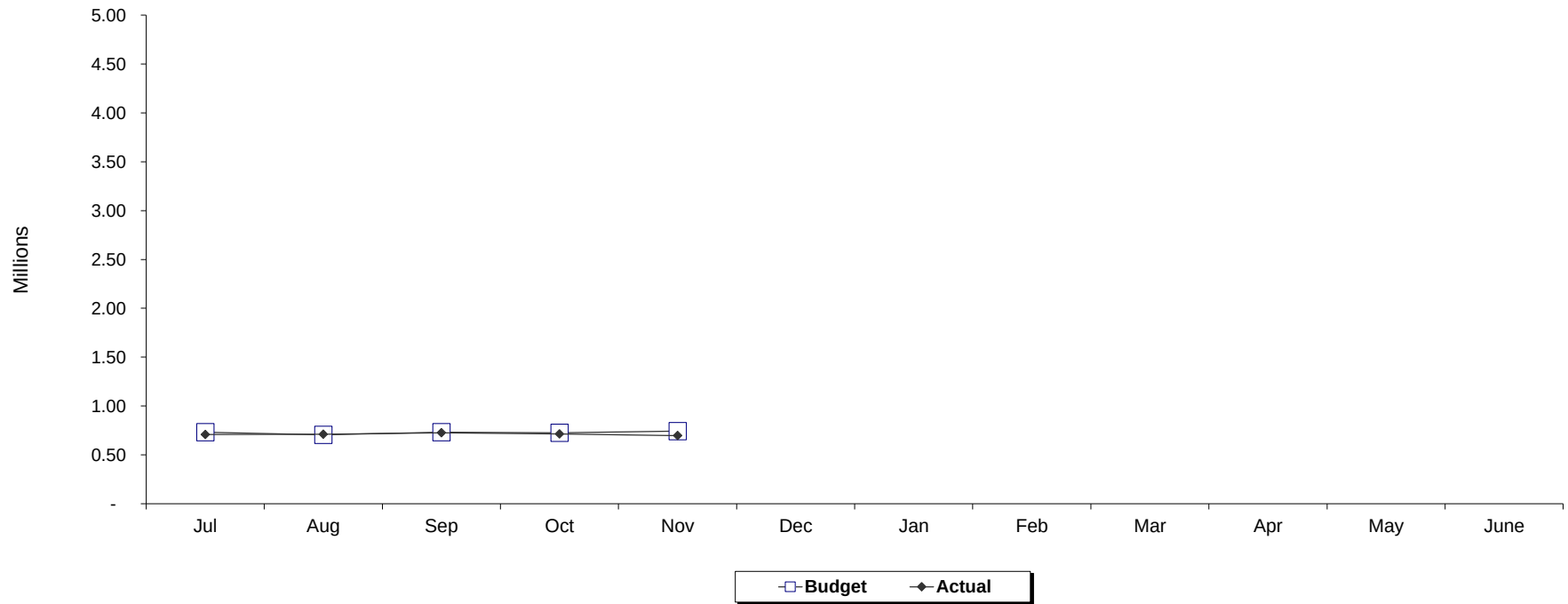

INSPECTIONS, CERTIFICATION, AND MAINTENANCE SERVICES**

ACTION

Staff proposes the Committee recommend the Board:

1. Award a contract to the lowest, responsive and responsible bidder, Battalion One Fire Protection (Battalion), in the total amount of \$337,065 for a five-year term.
2. Authorize the General Manager/CEO, or his designee(s), to execute a contract in full conformity with the terms and conditions of the solicitation documents.

SIGNIFICANCE

Approval of the above actions will provide the San Mateo County Transit District (District) with a qualified and experienced contractor to provide inspections, certification, and maintenance services of the District's permanent, fixed fire safety systems at North Base, South Base and the Central office. The systems to be serviced include fire sprinklers, smoke detectors and alarm control panels.

BUDGET IMPACT

Funds to support the award of this contract are included in the adopted Fiscal Year 2017 Operating Budget and will be included in future operating budgets.

BACKGROUND

The solicitation was advertised in a newspaper of general circulation and on the District's procurement website for interested bidders, including Small Business Enterprises (SBE) and Disadvantaged Business Enterprises (DBE) that are registered in the District's procurement database.

Five bids were received as listed below:

Battalion provided the lowest bid and, with the exception of minor irregularities that legal counsel determined could be waived, met all the bid requirements. References indicate that Battalion is a competent and recommended firm. As a result, Battalion was determined to be the lowest, responsive and responsible bidder.

The Office of Small and Disadvantaged Business Enterprises (OSDBE) assigned a 20 percent SBE goal to this project. The DBE Officer reviewed the bids submitted and, after a thorough analysis, it was determined that Battalion is a qualified SBE, and is the only firm that met the requirements of the District's SBE Program. Under the proposed contract, as a self-performing prime contractor, 100 percent of the total contract value will count towards SBE participation.

The District's most recent contractor was Siemens Industry at a five-year contract value of \$289,258.

Staff proposes the Committee recommend the Board reject the sole bid received in response to an Invitation for Bids (IFB) for the Rental, Purchase and Laundering of Work Clothing, Shop Towels and Related Items and authorize staff to re-issue the solicitation.

SIGNIFICANCE

Approval of the above action will permit the rejection of the sole bid received in response to the above referenced IFB and will allow Staff to re-issue the solicitation.

BUDGET IMPACT

There is no budget impact.

BACKGROUND

An IFB was posted on Public Purchase website to obtain bids for the Rental, Purchase and Laundering of Work Clothing, Shop Towels and Related Items. Staff advertised the IFB in a local newspaper of general circulation. Solicitation notifications also were sent to interested bidders. The San Mateo County Transit District (District) received one bid as listed below:

Upon review by staff and legal counsel, the sole bid was found to be non-responsive because the bid contained irregularities that cannot be waived and, therefore, the bid must be rejected. Aramark Uniform and Career Apparel, LLC (Aramark) submitted an incomplete bid because it failed to enter a price on some of the items listed on the Bid Forms. This solicitation required bidders to submit a price quote on all listed items.

The District's incumbent vendor is Aramark Uniform Services, a Division of Aramark Uniform and Career Apparel, LLC, which was awarded a five-year contract for a total estimated cost of \$269,186.

State

Marc Berman is the new member in this area who is succeeding termed-out Rich Gordon for the 24th Assembly District.

Federal

Director Jeff Gee said Assembly Bill x1 24 caught his eye about making the Metropolitan Transportation Commissioners be elected. Ms. Fromson said there has been some interest and pushed by different transit agencies to get more representation

ACTION

Staff proposes the Committee recommend Board adoption of the attached Legislative Program to guide the San Mateo County Transit District's (District) policy advocacy efforts over the course of the 2017 calendar year.

SIGNIFICANCE

The 2017 Legislative Program (Program) establishes the principles that will guide the District legislative and regulatory advocacy efforts through the 2017 calendar year, including the second half of the State legislative session and the first session of the 115th Congress. The Program is intended to be broad enough to cover the wide variety of issues that are likely to be considered during that time and flexible enough to allow the District to respond swiftly and effectively to unanticipated developments. Adoption of the Program provides our legislative delegation and our transportation partners with a clear statement of the District's priorities.

The 2017 Program is organized to guide the District's actions and positions in support of three primary objectives:

1. Maintain and enhance funding opportunities to support the District's programs, projects, and services.
2. Seek a regulatory environment that streamlines project delivery and maximizes the District's ability to meet public transportation service demands.
3. Reinforce and expand programs that build and incentivize public transportation ridership.

The Program is structured to apply these core objectives to a series of issues detailed in the 2017 Legislative Program.

Should other issues surface that require the District's attention, actions will be guided by the three policy objectives listed above. If needed, potential action on issues that are

unrelated to these policy goals will be brought to the District's Board of Directors for consideration.

The District and its legislative consultants will employ a variety of engagement tools to support the 2017 Legislative Program, including:

1. Direct Engagement

Engage policymakers directly and sponsor legislation, submit correspondence and provide public testimony that communicates and advances the District's legislative priorities and positions.

2. Coalition-based Engagement

Engage local and regional stakeholders to build awareness about specific issues and participate in local, regional, statewide and national coalitions organized to advance positions that are consistent with the 2017 Program.

3. Media Engagement

Build public awareness and communicate legislative priorities by issuing press releases, organizing media events, and through the use of social media and other electronic media.

BUDGET IMPACT

There is no impact on the budget.

BACKGROUND

Staff actively monitors legislative and regulatory activity and will seek Board positions on selected bills as appropriate to further the District's legislative objectives and to provide support for our advocacy efforts. Purpose

Legislative and regulatory actions have the potential to significantly benefit San Mateo County Transit District (District) programs and services. They also have potential to present serious challenges that threaten the District's ability to meet San Mateo County's most critical transportation demands.

The 2017 Legislative Program establishes the principles that will guide the District's legislative and regulatory advocacy efforts through the 2017 calendar year, including the first half of the 2017-18 State legislative session and 115th Congress. The program is intended to be broad enough to cover the wide variety of issues that are likely to be considered during that time and flexible enough to allow the District to respond swiftly and effectively to unanticipated developments.

Objectives

The 2017 Legislative Program is organized to guide the District's actions and positions in support of three primary objectives:

1. Maintain and enhance funding opportunities to support the District's programs and services.
2. Seek a regulatory environment that streamlines project delivery and maximizes the District's ability to meet transportation service demands.
3. Reinforce and expand programs that build and incentivize public transportation ridership, bike and pedestrian improvements, and transit-oriented developments.

Issues

The Legislative Program is structured to apply these core objectives to a series of State and Federal issues falling in these categories:

1. Budget and Transportation Funding Opportunities
2. Transportation Projects - Funding Requests and Needs
3. Regulatory and Administrative Issues

Within these categories are a detailed list of specific legislative initiatives and corresponding set of policy strategies.

Should other issues surface that require the District's attention, actions will be guided by the three policy objectives listed above. If needed, potential action on issues that are unrelated to these policy goals will be brought to the District's Board of Directors for consideration.

Budget and Transportation Funding Opportunities

<i>Issues and Background</i>	<i>Strategies</i>
<u>General</u> State investment in transportation operations and infrastructure continues to be underfunded despite a rebounding economy and the stabilization of the State budget. While some existing revenues have been protected from diversion, other funds remain vulnerable, and although some State bond revenues are still available to fund specified transportation projects, over \$200 billion in new revenue will be required to meet the State's infrastructure needs over the next six years. Since the gas tax has not been increased or adjusted for inflation since 1994, its buying power has been diminished, further depleting resources available to maintain, let alone expand or improve the state highway system or transit needs. A statewide advisory committee has been established to assess the implementation of pilot program for a mileage-based user fee as an alternative to the gas tax. Currently, there is a statewide pilot program with 5,000 participants to assess the implementation of mileage-based user fee. In addition, Governor Brown and legislative leaders are committed to finding new revenues for local streets and roads maintenance and rehabilitation, the state highway system, and funding for public transportation. <u>Existing Revenues</u> <i>Formula</i> After years of diversion to support the State's General Fund, funding for the State Transit Assistance (STA) program has remained stable over the last few budget cycles thanks to successful legal, legislative and political efforts on behalf of the transportation community. Still, more revenue is needed in order to meet the demand of increased ridership, reduce highway congestion – especially on Highway 101 – and adhere to the State's mandate of reducing greenhouse gas emissions, and creating livable communities.	<u>General</u> • Protect against the elimination or diversion of any State or regional funds that support San Mateo County transportation needs. • Support State funding allocation requests for investments that benefit San Mateo County transportation programs and services. • Work with statewide transit coalitions to identify and advance opportunities for funding that would support San Mateo County transportation priorities. • Monitor recommendations of the Road Usage Charge (RUC) Technical advisory Committee and implementation of a RUC program by the California State Transportation Agency (CalSTA). • Monitor and support efforts to study mileage-based user fee as a potential revenue source. • Support a funding package that will help address maintenance, rehabilitation, and congestion management needs in San Mateo County for programs that allow locals flexibility in leveraging funding for priority projects, such as congestion management and safety improvements on Highway 101, transit capital and operations, grade separations, bicycle and pedestrian programs, and local streets and roads. <u>Existing Revenues</u> <i>Formula</i> • Support the full funding of the STA program at levels called for in the 2011 reenactment of the 2010 gas-tax swap legislation. • Advocate for the regularly scheduled issuance of State infrastructure bonds that support San Mateo County's transportation services and programs. • Support legislation seeking to increase the sales tax on diesel, which serves as the primary source of funding for the STA program. • Advocate for the restoration of over \$1 billion in annual truck weight fee revenue and \$700 million in General Fund loan repayments, which can be used to support Measure A program priorities. • Support legislation clarifying the historic implementation of the STA program.

<i>Issues and Background</i>	<i>Strategies</i>
<i>Cap-and-Trade Revenues</i> In 2012, the State began implementing the cap-and-trade market-based compliance system approved as a part of the California Global Warming Solutions Act of 2006 (AB 32). The State estimates that the system may yield billions of dollars per year in revenues that will be allocated to various emissions-reducing projects and programs. In 2014, legislation was enacted creating a long-term funding plan for cap-and-trade which dedicates 60 percent of cap-and-trade revenues to transportation. The remaining 40 percent is subject to annual appropriation through the state budget process. SamTrans is eligible for funding through the Low Carbon Transit Operations Program, the Transit and Intercity Rail Capital Program and the Affordable Housing Sustainable Communities Program. Each programs requirements, oversight, and competitiveness vary. The programs require a certain percentage of funds be expended in state defined “disadvantaged communities” (as defined by CalEnviroScreen). This can prove difficult in jurisdictions with a small number of disadvantaged communities. <u>Ballot Measures and Voter Threshold</u> With over \$200 billion in unfunded transportation needs and funding from existing infrastructure bond measures waning, proposals for new local, regional and statewide transportation revenues are being discussed. Despite broad-based majority support for dedicating additional revenue to transportation services and programs, efforts to generate new revenues are often unsuccessful due to the requirement that certain measures receive two-thirds supermajority support from the Legislature and/or voters. In 2017, legislation may be considered that provides a framework for lowering the thresholds for the State or a city, county, special district or regional public agency to impose a special tax.	<i>Cap-and-Trade Revenues</i> • Work with the Administration and like-minded coalitions to secure the appropriation of additional cap-and-trade revenues to support San Mateo County transportation needs. • Support legislation and regional action that makes a broad array of San Mateo County emissions-reducing transportation projects, programs and services eligible for investment. • Protect existing cap-and-trade appropriations for transit operations and capital projects and sustainable communities strategy implementation. • Work to direct additional revenues to transit-eligible programs, including efforts to secure funding from the remaining discretionary funds and revenues dedicated to the high-speed-rail project. • Support efforts to revise the State’s definition on “disadvantaged communities” to encompass a larger proportion of disadvantaged communities on the Peninsula. <u>Ballot Measures and Voter Threshold</u> • Engage in efforts to generate new local, regional or statewide transportation funding and support proposals that adequately benefit SamTrans transportation needs. • Oppose efforts to add burdensome restrictions on the expenditure of these revenues, such as requiring payment for maintenance costs on the state highway system. • Support efforts to amend the State Constitution to reduce the voter threshold required for the State or a city, county, special district or regional transportation agency to impose a special tax for transportation projects or programs.

<u>Other State or Local Funding Options</u> With the State’s recent dissolution of redevelopment agencies, local and regional governments continue to seek methods for funding new infrastructure, facility needs, sustainability initiatives, and projects that will support ridership growth through a variety of methods. Various local jurisdictions around the state are looking to expand managed lane programs as a way of generating additional funding for highway maintenance and operations, and, possibly to support public transit in managed lane corridors. <u>Federal Impacts on State Funding</u> It is unclear what the new Trump administration plans to do regarding transit and how it will interface with California and its progressive policies. California currently leads the nation on a number of issues, including climate change, with transit playing a key role in achieving the state’s goals.	<u>Other State or Local Funding Options</u> • Advocate for legislation that would create new local funding tools to support transportation infrastructure and services. • Support innovative local and regional funding options that will provide financial support for SamTrans. • Support legislation that works to ensure revenues generated through managed lane projects remain in the County of origin. • Advocate for funding sources that would assist transit agencies in obtaining funds for sustainability initiatives including water conservation, waste reduction, long-term resource efficiency of facilities and equipment, and greenhouse gas reductions. • Support funding for workforce housing to attract and retain quality personnel. • Support MTC’s efforts to seeking authority for Bay Area voters to consider raising tolls on state- owned bridges to fund transportation improvements in bridge corridors (Regional Measure 3). <u>Federal Impacts on State Funding</u> • Monitor and respond, if needed, to state action re: potential loss or reduction in federal funding sources.

Transportation Projects – Funding Requests and Needs

<i>Issues and Background</i>	<i>Strategies</i>
<u>General</u> As the Bay Area’s population continues to grow, the region’s transportation infrastructure is being negatively impacted. Highways, local streets and roads are becoming heavily congested, Caltrain is nearing its capacity limits, and the demand for housing with easy access to public transit is increasing. <u>Caltrain Modernization Program (CalMod)</u> In 2012, the State Legislature appropriated \$705 million in Proposition 1A high-speed rail funds to modernize the Caltrain corridor and lay the foundation for future high-speed rail service. Under a multi-party regional funding agreement, this investment will be used to match a variety of local, regional, state and federal funding sources to electrify the corridor, install an advanced signaling system and replace Caltrain’s aging diesel trains with electric trains that will dramatically improve service between San Francisco and San Jose. <u>First and Last Mile Connections</u> Often times a barrier to taking public transit involves the difficulty in getting commuters on a transit system to their final destination that is not within walking distance. Transit agencies have supported various first and last mile transit options including bike share programs, vanpools, car share, shuttles, transportation network companies (such as Uber and Lyft), and new technology like e-bikes and e-scooters. <u>Grand Boulevard Initiative</u> The Grand Boulevard Initiative (GBI) is a collaboration of 19 cities, counties, local and regional agencies united to improve the performance, safety and aesthetics of El Camino Real. Starting at the northern Daly City city limit and ending near the Diridon Caltrain Station in central San Jose, the initiative brings together for the first time all of the agencies having responsibility for the condition, use and performance of the street.	<u>General</u> • Work with partners in the region to bring business, community, and transportation stakeholders together to enhance, support and advocate for transportation and mobility in the Bay Area. <u>Caltrain Modernization Program (CalMod)</u> • Advocate for the sale and allocation of Proposition 1A bonds to meet the commitments specified in SB 1029 with respect to the Caltrain corridor. • Support the allocation of cap-and-trade funding to advance implementation of the Caltrain Modernization Program. • Work with state, local and regional partners to advance policies and actions that will help secure funding needed to fulfill local and regional commitments to the Caltrain Modernization Program. • Work to address regulatory challenges that limit the implementation of solutions that will maximize Caltrain capacity and service benefits. <u>First and Last Mile Connections</u> • Support efforts to provide commuters with easy and convenient options to travel to and from major transit centers to their final destination. • Support the development of new and innovative first and last mile options. • Support increased funding opportunities for first and last mile projects. <u>Grand Boulevard Initiative</u> • Support funding for GBI projects like complete streets, bike and pedestrian projects, parking improvements, signal improvements, sustainability features like storm water capture, and transportation demand management features.

<u>Transit-Oriented Developments (TOD)</u> TODs create benefits to individuals, communities, and the region by providing mobility options, increasing public safety, increasing transit ridership and reducing roadway congestion, reducing vehicle miles traveled, decreasing GHGs, conserving resource lands and open space, and providing much needed housing on the Peninsula. <u>Other Projects</u> Beyond the CalMod Program, Caltrain has identified capital projects such as a fully electrified 8-car EMU fleet with longer platforms that will provide additional capacity and service benefits to Caltrain commuters. The capital needs also include but are not limited to grade separations and station upgrades. In 2016, a new round of HSR Blended System planning, outreach and environmental clearance work kicked-off in the corridor. HSR anticipates environmental clearance by the end of 2017. While this project is not being led by the JPB, the agency owns the right-of-way and has a significant interest in the process and success of the project that will “blended” with Caltrain service.	<u>Transit-Oriented Developments (TOD)</u> • Advocate for policies that promote transit-oriented developments near major transit centers. • Support the State’s GHG reduction goals by supporting TOD developments. • Support streamlining the process for TOD development. • Support state funding incentives for TOD development. <u>Other Projects</u> • Support the allocation of cap-and-trade or other state / regional funding to advance implementation of JPB projects. • Work to address regulatory actions or policies that negatively impact future capacity or service improvements. • Consistent with existing agreements between JPB and CHSRA, support efforts to plan, engage stakeholders, and implement the Blended System project on the Caltrain corridor.

Regulatory and Administrative Issues

<i>Issues and Background</i>	<i>Strategies</i>
<u>General</u> Every year a variety of legislation or regulatory action is pursued that would affect regulations governing transportation-related service operations, administration, planning and project delivery. In addition, opportunities exist to reform or update existing regulations that are outdated, or can be improved to address potential burdens on transportation agencies without affecting regulatory goals. <u>Zero Emission Bus Purchase Requirement</u> Implementation of the State's zero emission bus purchase requirement has been delayed repeatedly, but will eventually be required to achieve the State's mandated greenhouse gas reduction goals and the Air Resources Board could set minimum purchase requirements as early as 2017. <u>California Environmental Quality Act (CEQA)</u> Several regional and statewide transportation organizations continue working to modernize CEQA and minimize unnecessary delays during the environmental review process. <u>Sustainable Communities Strategies Implementation</u> In conjunction with AB 32 implementation, the Sustainable Communities and Climate Protection Act (SB 375) requires regions to develop Sustainable Communities Strategies (SCS) with integrated housing, land-use and transportation policies that will accommodate population growth and reduce regional greenhouse gas emissions by specific amounts. In 2013, regional authorities in the Bay Area approved Plan Bay Area, which includes the region's SCS.	<u>General</u> • Support opportunities to remove barriers to, and improve the ability to conduct, safe, efficient transportation operations, administration, planning and project delivery efforts, including alternative project delivery methods that provide flexibility to the District. • Oppose efforts to impose unjustified and burdensome regulations or restrictions on the District's ability to conduct efficient transportation operations, administration, planning and project delivery efforts. <u>Zero Emission Bus Purchase Requirement</u> • Monitor California Air Resources Board action on the implementation of the State's zero emission bus purchase requirement and support strategies that recognize and address the financial challenges associated with mandating the procurement of zero emission buses and other strategies supported by transit agencies to reduce fleet emissions. <u>California Environmental Quality Act (CEQA)</u> • Closely monitor efforts to modernize CEQA and support proposals that advantage transportation projects, including bicycle, pedestrian and transit-oriented development projects, without compromising CEQA's effectiveness as an environmental protection policy. • Support efforts to streamline project delivery including expedited reviews and approvals for large transportation projects such as HWY 101 HOV/HOT lane conversion and projects within the Dumbarton Rail Corridor. <u>Sustainable Communities Strategies Implementation</u> • Advocate for policies that provide adequate and equitable funding to support increased demand and dependence on San Mateo County's transportation services associated with the implementation of SB 375 and Plan Bay Area.

FEDERAL ISSUES

Budget and Transportation Funding Opportunities

<i>Issues and Background</i>	<i>Strategies</i>
<u>Federal Appropriations and Tax Extenders</u> Every year, Congress adopts several appropriations bills that cover 12 major issue areas, including the Transportation, Housing and Urban Development bill. These measures provide the authority for federal agencies to spend money during the upcoming fiscal year for the programs they administer. In December 2016, Congress passed a Continuing Resolution (CR) that funds the federal government until April 28, 2017. Congress will then have to pass a short term CR or omnibus appropriations bill to fund the government for the remainder of fiscal year 2017, which ends on September 29, 2017. Congress also considers legislation that governs tax and finance issues that impact transit agencies. <u>Surface Transportation and Rail Authorization</u> In 2015, Congress passed Fixing America's Surface Transportation (FAST) Act, a five year bill that establishes funding levels and federal policy for the nation's highways and public transit systems through Fiscal Year 2020. While the FAST Act included significant benefits for transportation agencies, it did not address several critical issues including the long-term solvency of the Highway Trust Fund. BACKGROUND

STATE ISSUES

As of 12/20/16:

On December 5, 2016, the Senate and Assembly both convened at noon to swear in new members. There are nine new members in the 40-member Senate and 22 new members in the 80-member Assembly. Overall, this represents a large turnover of new members. Democrats have two-thirds supermajority in both houses of the legislature.

On December 5, 2016, Assemblymember Jim Frazier and Senator Jim Beall introduced transportation funding bills (Assembly Bill 1 and Senate Bill 1). Attached is a comparison chart of the two bills.

The 2017 calendar year legislative deadlines:

- January 4, the Legislature reconvenes
- January 10, budget bill must be submitted by Governor Brown
- February 17, last day for bills to be introduced
- June 2, last day to pass bills out the house of origin
- June 15, budget bill must be passed
- September 15, last day for any bill to be passed
- October 15, last day for Governor to sign or veto bills

Last year, the Legislature sent Governor Brown 1,059 bills. 900 became law and 159 were vetoed.

FEDERAL ISSUES

As of 12/20/16:

Congress adjourned on December 9, 2016 for the 114th Session. Before adjourning, Congress adopted a short-term Continuing Resolution that will fund the government through April 28 at Fiscal Year 2016 levels.

Senator Kamala Harris, who replaced retiring Senator Barbara Boxer, received her committee assignments. She will be on the following committees:

- Homeland Security and Governmental Affairs Committee
- Select Committee on Intelligence
- Environment & Public Works Committee
- Budget Committee

The Environment and Public Works Committee is an important transportation related committee in the Senate. Former Senator Boxer was the ranking member on the committee and it is helpful that Senator Harris will continue to represent California interests on this committee.

The 115th Congress will convene on January 3rd and the inauguration of the next President will be on January 20th.

Chair Kersteen-Tucker said over the past month she was sad to see Eli Kay, Chief Financial Officer, Shweta Bhatnagar, Manager, Government and Community Relations

and Jayme Ackemann, Director, Marketing and Communications, leave the firm. She said she is concerned about the trend of employees leaving and hopes the employee hotline is working so employees have a place to voice their concerns. She asked how the hotline is handled, if there are any themes and are responses being given.

Jim Hartnett, General Manager/CEO said the circumstances of the three employees leaving have nothing to do with a hotline. The hotline continues to be advertised on the internal website and in his "Message from Jim." There have been no calls since before September.
